
N O T I F I C A T I O N

The stamp duty on sale consideration fixed vide notification referred to in preamble (1) and (2) is hereby revised as under with immediate effect.

Considering the representation of various agencies/public representatives/associations/individusls, the Committee under the Chairmanship of Development Commissioner, DD&DNH examined the issues from various aspects, and as per the approval accorded by Hon'ble Administrator, DD&DNH, it has been decided to revise the stamp duty on sale consideration as under.:-

- (1) Stamp duty on sale consideration in case of tribal to tribal is reduced from 4% to 01 % (one percent)
- (2) In all other cases stamp duty on sale consideration is reduced from 4% to 2% (two percent)
- (3) The stamp duty on Mortgage Deed/Lease Deed/Equity Deed is reduced from 4% to 01% (one percent)
